

IRA HOME ENERGY REBATES

Home Efficiency Rebate (HOMES)



The Home Efficiency Rebates Program (HOMES), is designed to help you save energy and reduce costs. HOMES will provide rebates to reduce the cost of energy-saving, whole-home improvements in existing single-family and multifamily buildings.

HOW TO PARTICIPATE

We will be with you every step of the way. Here's what you can expect:

1

Where do I Start?

By pre-qualifying for the program, you will learn what rebates you may be eligible for. If you qualify for income-based rebates, you will be asked to provide additional information to verify your household details.

2

Finding a Trusted Partner

After determining your eligible rebate level, the next step is to select an IRA Registered Contractor. From conducting an energy assessment to securing your rebate, these contractors will guide you through each stage of the program.

IRA Registered Contractors meet strict program standards for certification, licensing, and training. To qualify for rebates, all work must be completed and submitted by one of these approved contractors. They handle the process from start to finish, including managing forms, approvals, and other necessary steps, ensuring a smooth experience for participants.

Get an Assessment

A home energy assessment must be done before any work is started. Understanding how your home uses energy will help you and your energy assessor create a project plan. An energy model of your home predicts how much energy you will save. You will receive an energy report, detailing energy-saving home improvements. Be sure to ask questions and understand the different upgrade options available to you.

Low-income households are eligible for up to a \$500 rebate to help cover the cost. Tax credits to help offset these costs are also available. Ask your energy assessor for more details.

Project Savings

Households qualify for rebates based on how much energy they're expected to save and their household income. The more energy you save, the higher available rebates. Projects must reduce energy usage by at least 20% to qualify.

5

Enjoy Upgrades and Savings

Once your energy efficiency upgrades are complete, your IRA Registered Contractor will submit your project for payment. You will receive an installation certificate showing all the improvements made as part of your HOMES project.
