## Geothermal Heat Pump System: \$750

# Geothermal Heat Pump System: \$1,000

· Limited to customers of a participating natural gas and electric utility.

### **Geothermal Heat Pump Requirements**

- System must have a coefficient of performance (COP) equal to or greater than:
  - 3.6 for a Water-to-Air System.
  - 3.1 for a Water-to-Water System.
  - 3.6 for a Direct Ground Exchange (DGX).
- · System must have an energy efficiency ratio (EER) rating equal to or greater than:
  - 17.1 for a Water-to-Air System.
  - · 16.1 for a Water-to-Water System.
  - 16.0 for a Direct Ground Exchange (DGX).
- EER and COP are based on the AHRI database, found at ahridirectory.org.
- Large commercial (i.e., three-phase) units are ineligible under this application. Contact your Focus on Energy Advisor for more information. Visit focusonenergy.com/energy-advisors to find your Energy Advisor.
- Unit must be ENERGY STAR® certified. A Pre-Qualified Equipment List is available at focusonenergy.com/geothermal.
- System must be the heating and cooling source for the site.
