

IRA HOME ENERGY REBATES

Home Electrification and Appliance Rebate (HEAR)



HEAR offers rebates to households installing heat pumps and other energy-efficient electric equipment, supporting home electrification efforts. HEAR rebates are tailored to help low- and moderate-income households save energy and cut costs on upgrades made to their primary residence.

A home assessment isn't required. In most cases, qualifying equipment will be purchased through your local participating IRA Registered Contractor.

HOW TO PARTICIPATE

We will be with you every step of the way. Here's what you can expect:

1

Complete Income Qualification

All participating households must verify their total household annual income is less than 150% of the Area Median Income (AMI). A total household includes all individuals living in the home, regardless of relation. You may be asked to provide additional information to verify income.

2

Select Your IRA Registered Contractor or Qualifying Equipment

Once you know what rebates you are qualified for, there are two different ways to participate.

Using an IRA Registered Contractor

Most HEAR rebates will require working with an IRA Registered Contractor. These trusted program partners help you choose the best qualifying equipment for your home. They will guide you through the program, purchase, and installation for your project.

Installing or Purchasing Equipment Yourself

Purchase from any store or website that carries qualifying products, if your HEAR project involves upgrading qualifying kitchen or laundry equipment or self-installing an ENERGY STAR® electric heat pump water heater.

Equipment Installation

Have your new energy-efficient upgrades installed. Your rebate may come as an instant discount on your invoice or mailed to you as a check.
